



FOREIGN INVESTMENT IN CANADIAN EQUITIES

In the first two months of 2015, foreign investors acquired \$2.6 billion of Canadian equities. In 2014, there were net foreign inflows into Canadian equities in the amount of \$24.5 billion compared with an investment of \$18.2 billion in 2013.




