A RECORD YEAR FOR NEW ETF LISTINGS ON TSX!

A record 77 new ETFs listed on TSX in 2016.* At year end, a grand total of 454 ETFs with a total market capitalization of almost \$114 billion called our Exchange home. TSX also welcomed six new ETF providers, increasing the overall number of listed ETF providers to 18.

.U, .V	Trading in U.S. funds


ENHANCEMENTS TO EXCHANGE TRADED FUND (ETF) VOLATILITY MECHANISMS

Over the past year, TSX collaborated with ETF market makers and issuers to review current volatility mechanisms and developed several action items designed to further improve market quality for ETF trading, which came into effect November 21, 2016.



CANADA ETF TRADING VOLUME


ETF VOLUME TRADED (MILLIONS)
