Despite volatility in the market during the first three months of 2018, Canadian investors continued to pour money into ETFs. Assets under management from ETFs listed on TSX reached an all-time high of \$149B at the end of March. The Q1 2018 TSX ETF Report provides a deeper dive on the activity in the ETF space on TSX.

Bristol Gate Capital Partners Inc.

Bristol Gate Capital Partners Inc. launched their first two actively-managed ETFs on February 21, 2018. The U.S. Concentrated ETF (Canadian dollar: TSX: BGU, U.S. dollar: TSX: BGU.U) and the Canadian Concentrated ETF (TSX: BGC) leverage their proprietary machine-learning model to predict dividend growth and combines it with fundamental analysis to build concentrated portfolios of the best dividend growers in their respective universes.



Founded in 2006, Bristol Gate has been at the forefront of using data science in investment management. The ETFs are based on strategies that have been running for almost 5 years for the Canadian strategy and almost 9 years for the U.S. strategy. Both strategies seek to achieve above market returns with less downside risk over time.






TSX ETF Sector Overview


