



# Toronto Stock Exchange ETF Report

# Not Much Time to Celebrate

The first quarter of 2020 kicked off with a couple of major milestones within the Canadian ETF industry. By the end of January 2020, the market cap was at its all-time high of nearly \$207 billion. Then the Toronto Stock Exchange (TSX) celebrated the 30th anniversary of the launch of the world's first exchange-traded fund (ETF), the Toronto 35 Index® Participation Units, or TIPs®. TIPs evolved into what we know today as the iShares S&P/TSX 60 Index ETF (TSX:XIU).

However, not too soon after celebrations of these momentous occasions in Canadian ETF history ended did another momentous event occur when COVID-19 became a reality. The virus had a dire impact on the markets, employment, social norms and most importantly the human toll felt across Canada and around the world. Being in Canada we are very fortunate to have a strong medical system that is built and supported by a solid foundation of amazing frontline workers to whom we are all deeply thankful. Our attention while working from home turns to the role we play in the post-COVID-19 economic recovery.

The S&P/TSX Composite Index, during the month of March, dropped by 37% from its all-time high of 17,944.1 on February 20, 2020, to 11,228.5 on March 23, 2020. Subsequently the market cap of the Canadian ETF Industry at the end of March had dropped to just over \$185 billion. While no one is willing to officially call the bottom, one must look at our recent historical experience during the financial crisis in 2008-2009 as a potential guide to our future. March 9, 2009, was the official bottom of the S&P/TSX Composite Index, with a value of 7,566.9. However shocking the index level may have been, the real story is that 10 days following the bottom the S&P/TSX Composite Index increased 18%, followed by 21%, 39%, 45% and 58% at the 1-month, 3-month, 6-month, and 1-year points post-market-bottom of the index<sup>1</sup>, respectively.

The question that looms in this new COVID-19 reality is whether Canada has seen the market bottom or is this a minor recovery in preparation for a second wave of the virus and volatility in the second half of 2020? The TSX provides access to over 730 ETF solutions across 36 providers to participate in this current recovery and the tools you can use to help protect your portfolio from the potential of future volatility.


