Canadian ETF industry keeps trekking forward

It's with little surprise that 2020 is shaping up to be a remarkable year. Considering all the upheaval, it's refreshing how well the Canadian ETF industry has fared. It has been robust and barely missed a beat. With three quarters of the year behind us, the Canadian ETF industry has already amassed more net flows into ETFs than any previous year (\$32B YTD vs. \$20B in all of 2019).

In January, it might not have seemed so ridiculous to expect to see 2020 to be yet another record year but come mid-March the thought of where we are today seemed very far fetched. Globally, ETF flows are also on a record pace. **ETFGI** recently reported that global ETFs have seen approximately US\$500B in net new assets in the 8,400 ETFs globally.

Digging deeper, we see 57 cents of every net new dollar put into Canadian-listed ETFs flow into equity funds (\$18.5B YTD). According to **National Bank Financial**'s research, Canadian and US equity funds continue to dominate the equity flows, each gathering approximately a third of equity directed dollars. Multi-asset and portfolio funds continue to be popular with investors, accumulating nearly \$2B in new assets year to date. Fixed income funds have garnered roughly \$11B in new assets year to date.

Canadian ETF providers have clearly signaled their confidence and commitment to the market with a very healthy 111 new ETFs this year (also a record) and added 4 new ETF providers.

As we approach year end and look towards 2021, we are busy reflecting on how and what are the best ways to interact with investors and the ETF community. Since the pandemic hit, we shifted our TSX ETF Lunch and Learn series and our TSX Institutional ETF conference to virtual. Thank you to everyone who has participated and listened in. While we are very pleased with the results, we are striving to find new and innovative ways for investors, advisors and the greater ETF community to learn and adapt to using ETFs. 



MX ETF Sector Overview


ETF Options Average Daily Volume and Open Interest
