Four Takeaways For CPC Stakeholders

TSX Venture recently announced major enhancements to its Capital Pool Company (CPC) program. See below for our Four Takeaways regarding these policy changes. **Click here** for more information.

1. FLEXIBILITY TO COMPLETE QTs

The two-year limit for completing a Qualifying Transaction after listing of a CPC has been removed to provide CPC founders greater flexibility to source high quality target companies for their QT.

2. \$10,000,000 MAXIMUM CAPITAL RAISE

CPCs will be allowed to raise a maximum of \$10 million (in aggregate), up from \$5 million. This increase can make CPCs more attractive to target companies with higher cash needs.

3. COMPENSATION ENHANCEMENTS

CPC founders will have greater incentives to participate in the CPC program by allowing founders to subscribe for a greater amount of discounted seed capital, allowing stock options to be priced at a discount to the IPO price, and providing a more attractive escrow release timeline.

4. AMENDED LISTING REQUIREMENTS

The initial listing requirements for CPCs have been reduced from a minimum of 200 public shareholders to 150 and from a total float of at least 1,000,000 shares down to 500,000 shares.


