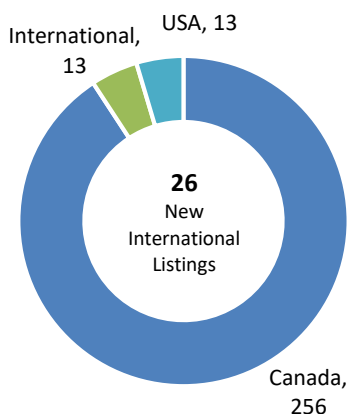

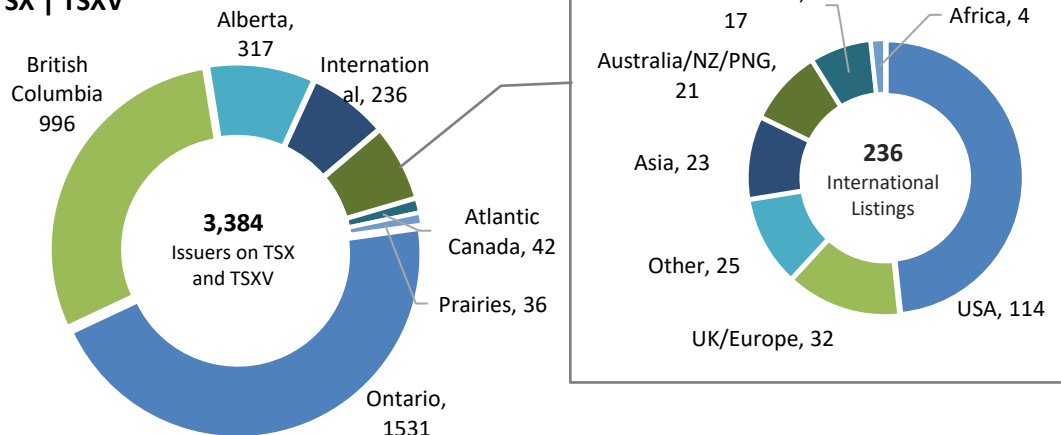

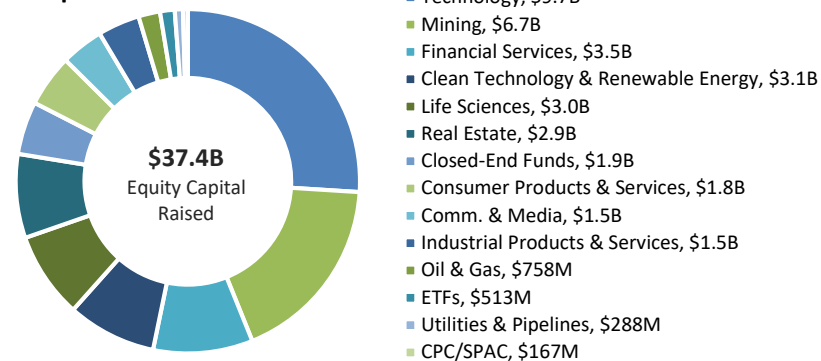

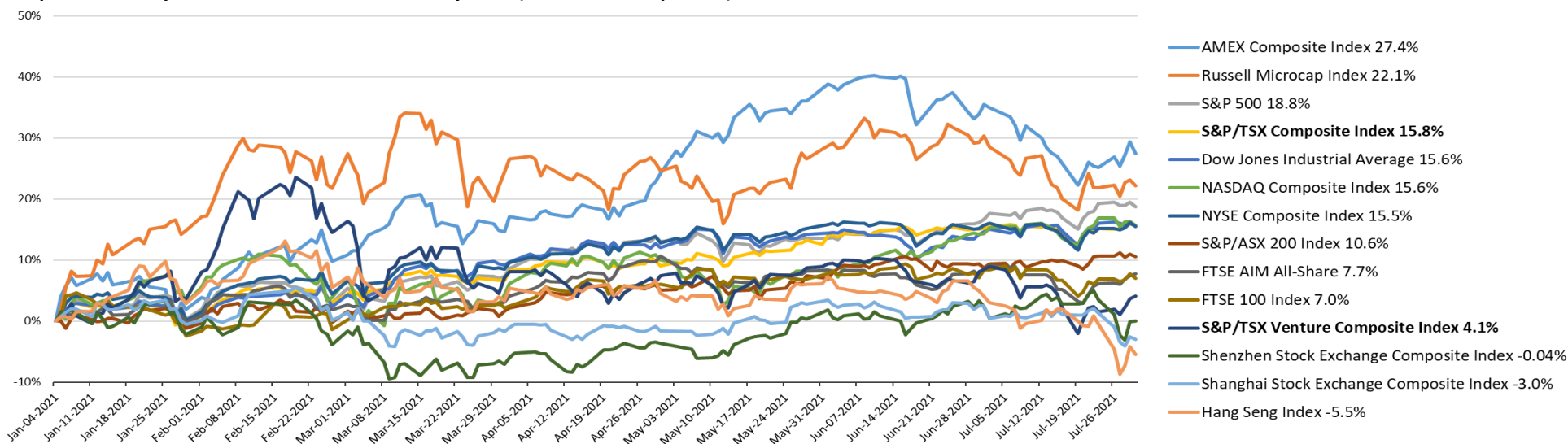

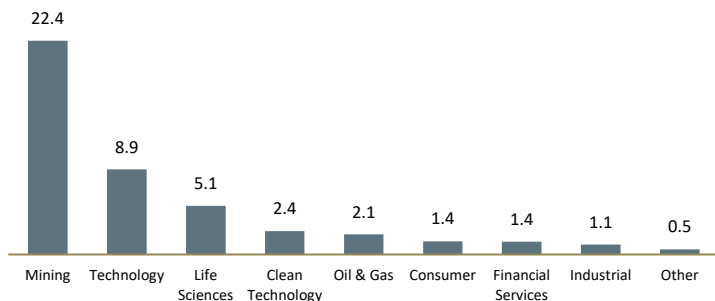
Comparison of Major Index Performance -- YTD July 2021 (Source: S&P Capital IQ)



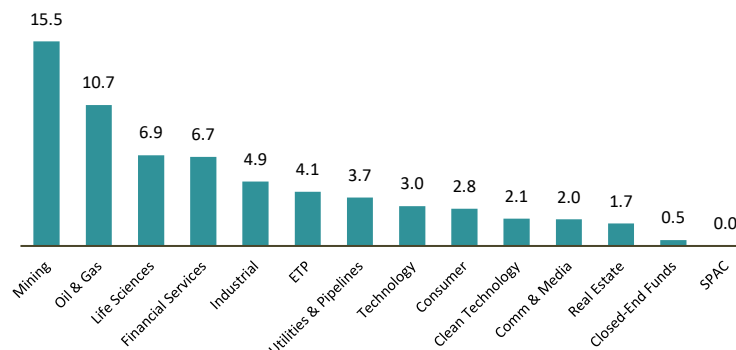
