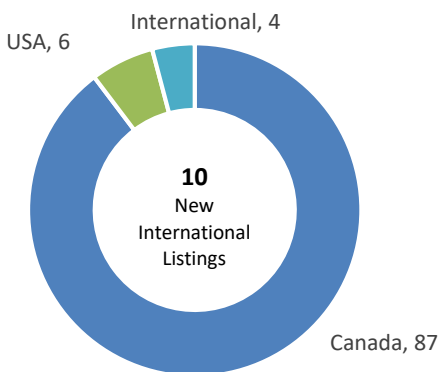

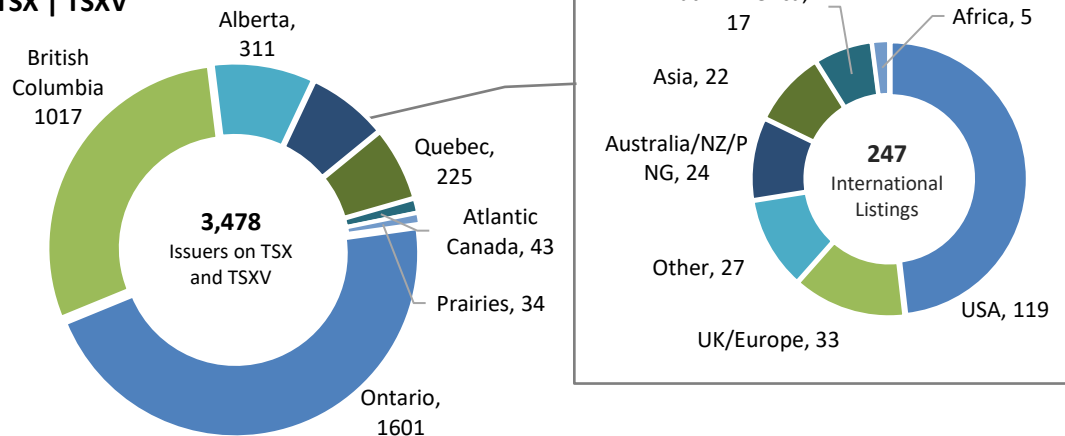

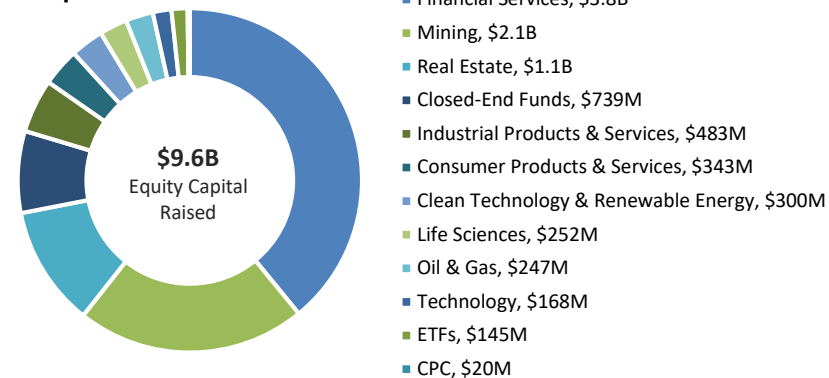

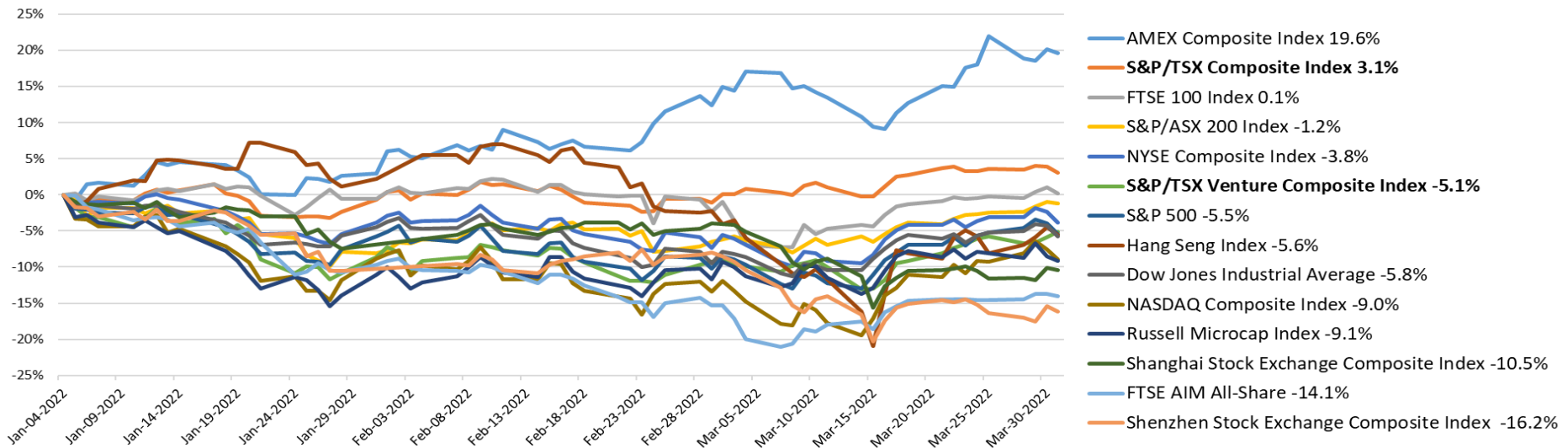

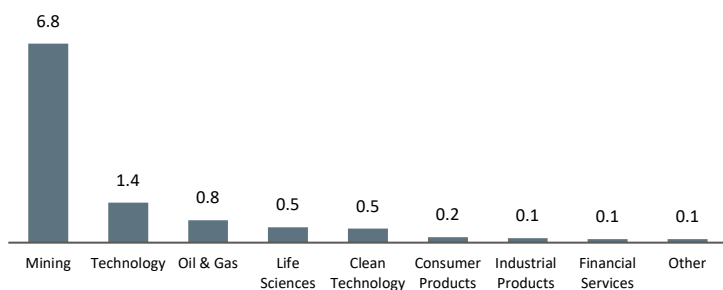
Major Global Index Performance -- YTD March 2022 (Source: S&P Capital IQ)



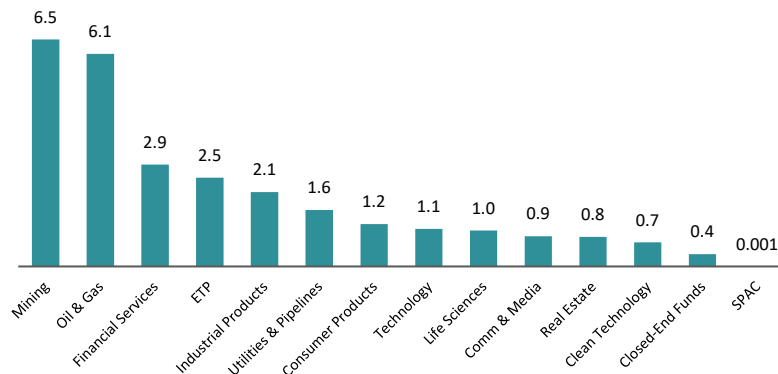
