



Toronto Stock Exchange ETF Report

The first quarter of 2022 introduced 32 new ETFs and 3 conversions from closed-end funds across 14 different ETF issuers, for a total of 908 ETFs currently listed on the Toronto Stock Exchange. In addition to the new ETFs, the Toronto Stock Exchange welcomed Canada's newest ETF provider Mulvihill Capital Management and their listing of Mulvihill Canadian Bank Enhanced Yield ETF (TSX:CBNK).

The TSX ETF sector continues to grow with over \$331.4 billion in assets under management and over \$188.9 billion in value traded on TSX-listed ETFs, representing an increase in value traded of 26% over the first quarter of 2021. This growth in the ETF industry was helped by the introduction of the world's first bitcoin ETF that recently celebrated its 1-year anniversary, an asset class that now has approximately \$6 billion in AUM.

The year ahead looks promising for the Canadian ETF industry as we can anticipate ETF providers to continue to round out their product shelves.

LOOKING AHEAD INTO THE BALANCE OF 2022

Much like how COVID-19 first gripped the world and its markets back in early 2020, the current environment faces additional headwinds with the uncertainty around the war in Ukraine, and rising inflation and interest rates. The breadth and depth of ETFs available on the TSX shelf provide both investors and advisors the tools that they need to navigate through the uncertainty of the current environment





MX ETF Sector Overview


ETF Options Average Daily Volume and Open Interest
