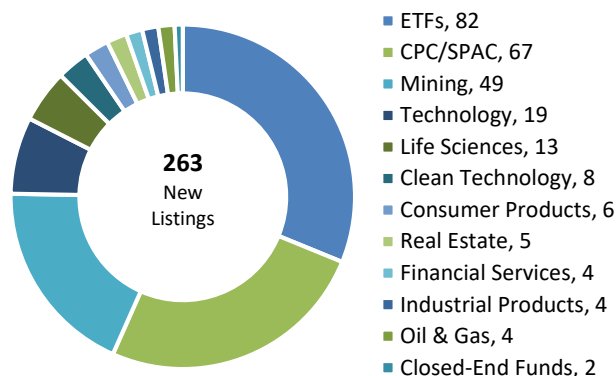

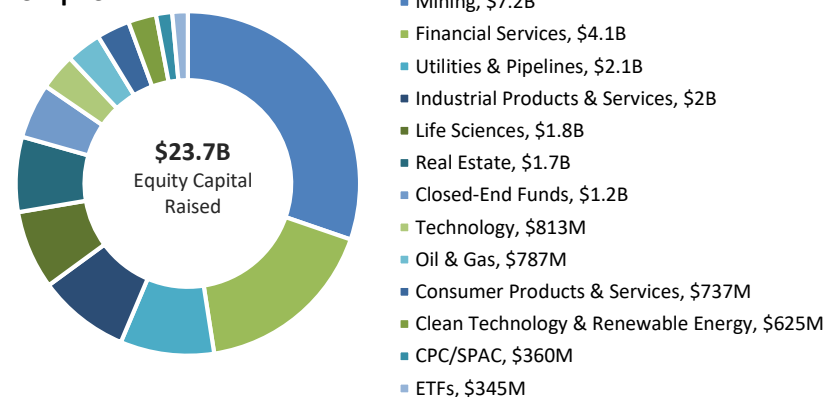

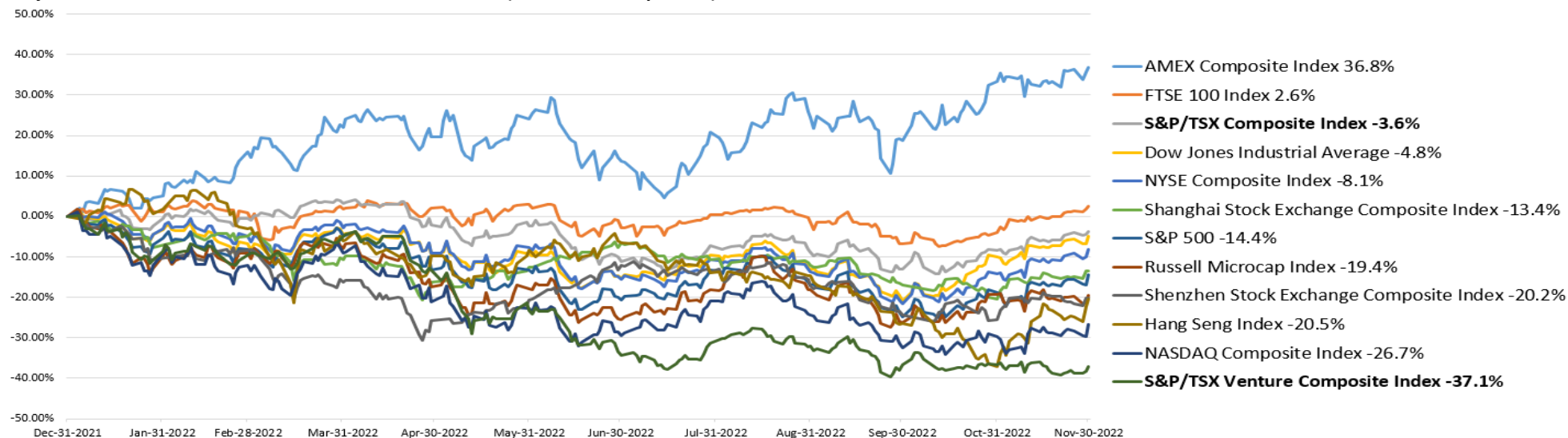

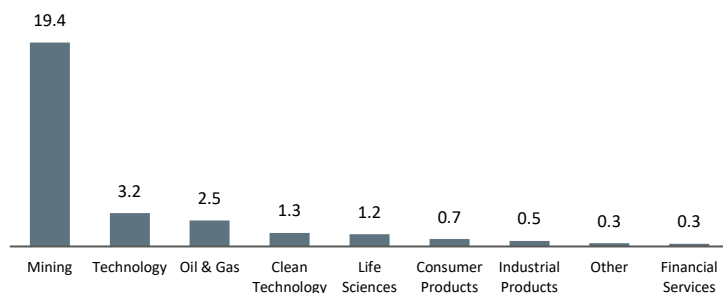
Major Global Index Performance -- YTD November 2022 (Source: S&P Capital IQ)

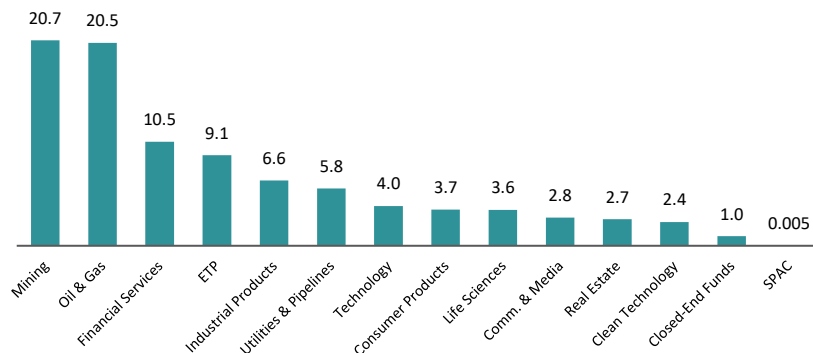
Volume Traded YTD November 2022 on TSXV by Sector (Billions of Shares)
