



Toronto Stock Exchange ETF Report

The second quarter of 2023 was a robust period for ETF launches in Canada as the TSX listed a total of 30 new ETFs from six different ETF providers. According to National Bank's ETF research team, \$9B in net new dollars flowed into Canadian ETFs in the second quarter bringing the total for 2023 up to \$19.7B year to date. Fixed income and high interest savings account ETFs continue to gather the most assets while equity ETFs gathered up most of the remaining new dollars.

Total ETF assets under administration in Canada at the end of June were \$347.5B according to the ETF research published by TD Securities.

The TSX has partnered with the Canadian ETF Association (CETFA) to record and distribute nearly 50 "ETF 101" videos available in English and French. These videos were produced in partnership with most of our Canadian ETF providers, with the goal to educate investors and advisors about investing in ETFs. The TSX team along with 21 different ETF providers and our friends from S&P Dow Jones held 4 ETF events in Montreal, Calgary, Vancouver and Toronto this spring. This fall's edition of the TSX ETF Lunch and Learn series will be heading to Quebec City and Winnipeg as well as Montreal, Toronto and Vancouver.




MX ETF Sector Overview
