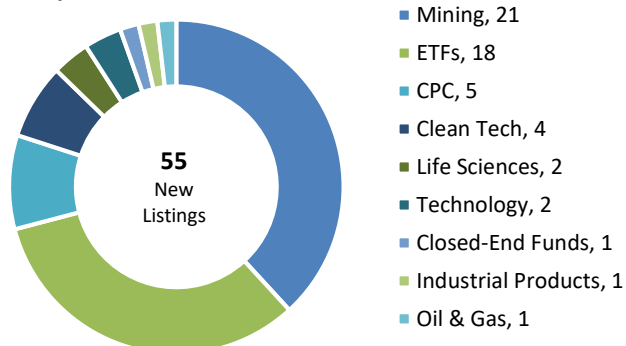

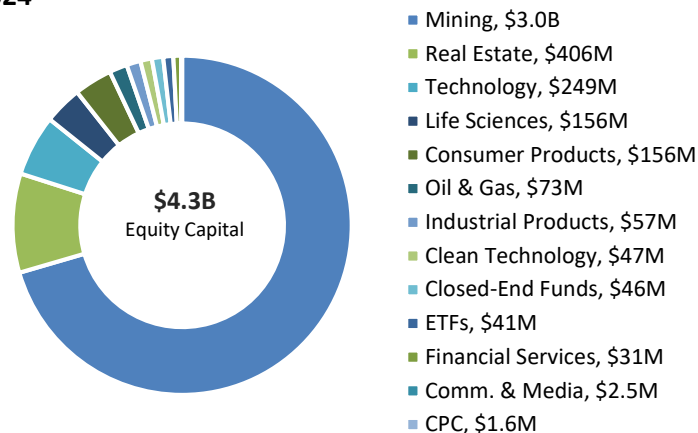

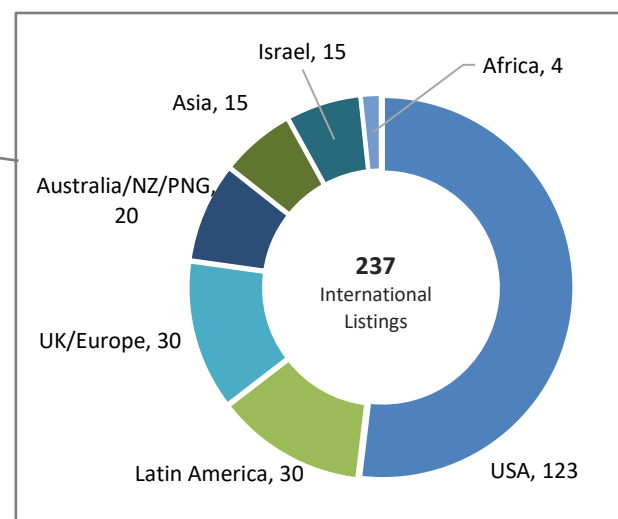

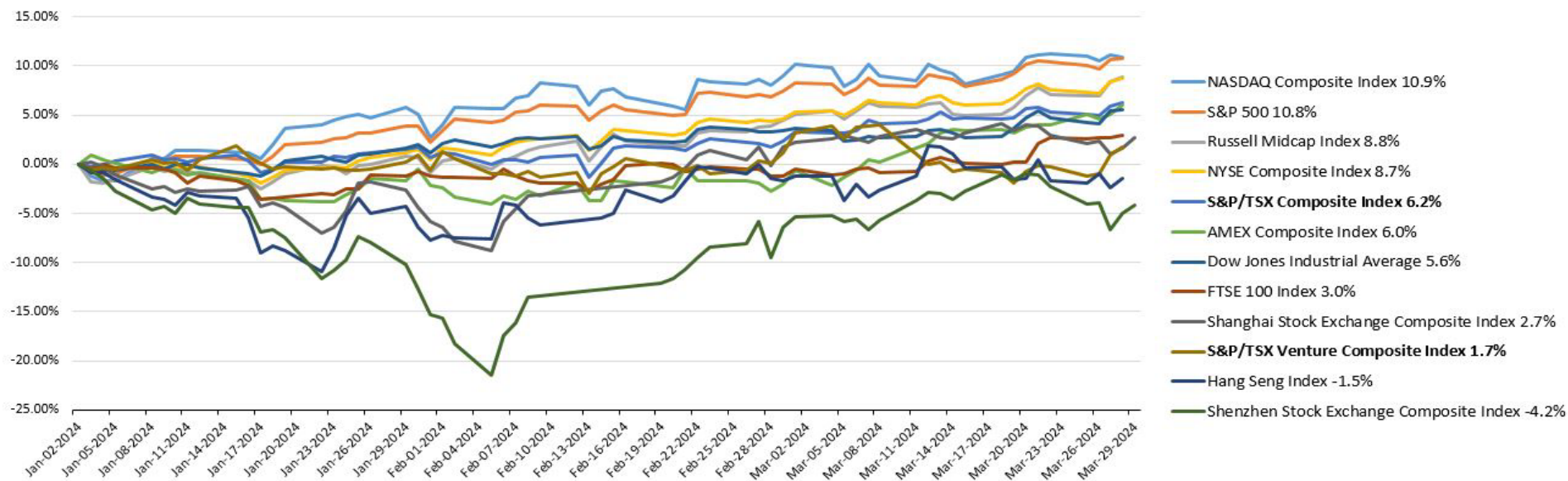

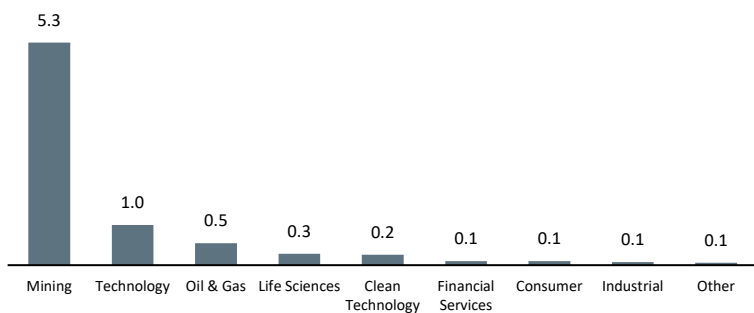
Major Global Index Performance -- YTD March 2024 (Source: S&P Capital IQ)

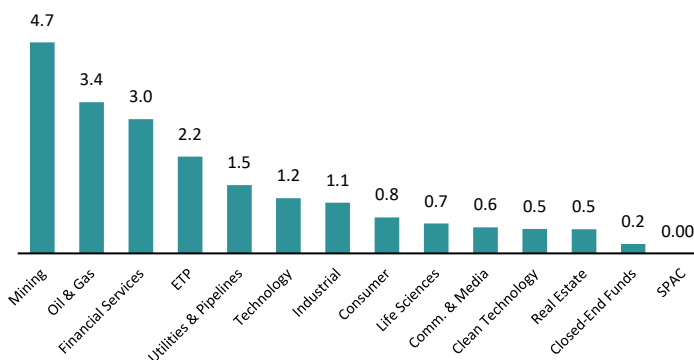
Volume Traded YTD March 2024 on TSXV by Sector (Billions of Shares)
