ETF Report

The third quarter of 2024 was a robust quarter for not only new listing of ETFs on the Toronto Stock Exchange (TSX) but also for net new flows of money into Canadian ETFs. Over the course of the quarter, we saw more than \$15B in new money invested in Canadian ETFs according to the Investment Funds Institute of Canada (IFIC.ca). Year to date, National Bank Financial reports inflows of \$49B into ETFs.

Fourteen different ETF issuers launched a total of 34 new ETFs this quarter. This is up from 25 listed in the third quarter of 2023. So far this calendar year (up to September 30th), the TSX has listed 101 new ETFs. The breadth of new ETFs this quarter ran from actively managed bond ETFs to broad based index products to our first single stock ETFs to both equity and fixed income option writing strategy ETFs.

The TSX also welcomed Corton Capital in September as they launched their first ETF, Corton Enhanced Income Fund (TSX: RAAA). As mentioned above, this quarter, the TSX also welcomed the first single stock ETFs listed on our exchange as Harvest ETFs launched their high income shares suite of ETFs.

As the quarter closed, BlackRock, S&P and TMX Group celebrated the 25th anniversary of creation of the iShares S&P/TSX 60 Index ETF (TSX: XIU). XIU's roots are the original TSX managed Toronto Participation Units (TIP & HIP) listed in 1990. In 1999, TIP & HIP combined to form XIU and started tracking the new S&P/TSX 60 index. In March of 2025, the TMX Group is looking forward to celebrating the 35th anniversary of the listing of theworld's first ETF(TIP).




